Executive Director Report: Pat Albaugh noted that the Port of Cascade Locks has issued a press release today indicating they have signed an agreement with American Cruise Lines. He noted several items from the press release. Commissioner Kingston expressed concerns of how this will impact the use of the Stevenson Landing. Activity at the Port is increasing with the arrival of spring. We have the local Master Gardeners group working on flower beds on the waterfront and he noted receiving other volunteer interest.

Attorney's Report: No Notables to Report

Finance Report: Cindy Bradley presented the March financial report. Notable income and expenses were reviewed. She noted that the interest rate for the Local Government Investment Pool (LGIP) is nearing five percent (5%). American Queen Steamboat Company (AQSC) is delinquent on the first half of the year and all other tenants are current.
