Executive Director Report: Director Albaugh remarked that the Port should be proud of their current financial position while continuing to complete projects and improve Port properties. The position also allows the Port provided security to take advantage of opportunities as they arise. He met this past week with Sarah Kohout of Marie Perez's office, and it appears that the federal appropriation may not be in jeopardy but is still not guaranteed. The Chamber of Commerce will be remodeling their office. They have contacted the Port regarding short-term options for January through March 2024. Since the Tichenor Suite 40 is unoccupied he asked to consider holding the space for their use. He recommended working with them as a community economic partner. The U.S. Army Corp of Engineers has indicated they will be issuing a lease upon completion of a pending land survey.

Facilities Update: Doug Bill informed the Commission the facilities staff are in the processes of winterizing outdoor restrooms and will soon begin on holiday lighting. The boat launch dock has been removed for repairs due to damage sustained from high east winds. The annual LNI consultation is scheduled for November 16th. On December 6th and 7th, the annual testing of the fire alarm system and fire extinguisher inspections have been scheduled for the Tichenor, River Point and Teitzel Buildings. The Tichenor building has also been scheduled for a five-year inspection of the Sprinkler System. It was noted that the Beacon Rock Golf Course club house needs a roof.
